Call To Order

Dolsby called the meeting to order at 10:01 AM. Dolsby welcomed everyone to the April 2024 Board meeting and went over the open meeting law. Dolsby thanked Rivaura Winery for hosting the board meeting.

Legislative Report

Roger Batt advised just prior to the meeting that he would not be in attendance.

<u>Cragin moved to renew Legislative Educator Roger Batt's contract at \$21,000 for the 24/25</u> <u>fiscal year. Seconded. Motion carries.</u>

Dolsby asked if any legislation is needed for the 2025 session because as a state agency we

have to submit ideas to the Governor in June. The IWC has received zero responses when the industry was asked. Nederend doesn't feel like there is anything on the State side of issues that are needing changed. Batt can help advocate for the University of Idaho position.

Presentation – University of Idaho - Dean Michael Parrella

Dean Michael Parrella presented information on his background at UC Davis. He is in his ninth year as the Dean of the College of Agriculture.

University of Idaho Parma Extension Center hired an entomologist. They are now looking to hire a new pomologist. USDA doesn't have any faculty at Parma anymore, and transferred vineyards to the University of Idaho.

In the 2025 Legislative session, the University of Idaho plans to ask the JFAC committee for funding for the Viticulture and small fruit extension agent for Parma. Dean Parrella is looking for feedback on the job description and would like us to be a part of the search. Jake Cragin would like to be a part of the hiring process. Hiring will happen in the summer of 2025. The position would be 30% research + state-wide responsibility.
