- Primary Election
 - There are several good candidates challenging incumbents this year
 - Batt stated he will send an update after the election with results and how that impacts the industry
- State Agencies negotiated rulemaking
 - o rulemaking regarding well construction & water temperature standards and anticipate other topics of interest to emerge between now and August

House Bill 608aas

- With the passage of House Bill 608aaS during the 2024 Session we anticipate another round of discussions to begin soon regarding additional incentives to preserve farmland with the intent to draft Legislation for the 2025 Session to build upon the Agriculture Protection Area statute that will go into effect on July 1.
- University of Idaho new Extension Agent
 - The Idaho Grape & Wine Commission will be meeting soon with members of the University of Idaho College of Agriculture and Life Sciences to discuss the steps in obtaining a new Extension Agent and the best approach to obtaining funding for this position through the 2025 Appropriations process.
 - Batt has a meeting scheduled for 5/29/24 to begin talks with Legislators regarding the new Extension Agent
