Call To Order

Dolsby called the meeting to order at 9:04 AM.

Approval of Minutes

Dolsby presented the April 2023 Minutes. With no need for discussion, Potter moved to approve the minutes. Seconded. Motion carries.

Dolsby welcomed everyone to the May 2023 Board Meeting and thanked Rolling Hills Vineyard for hosting. She introduced our new intern, Ande Diggins. Dolsby mentioned the Idaho Wine Commission's new board member, James Nederend. Dolsby thanked Crystal Potter for her time and dedication to our industry.

Northern Idaho Update - Melissa Sanborn, Colter's Creek Winery

Melissa Sanborn, with Colter's Creek Winery, gave a Northern Idaho update to the Board.

Sanborn's highlights included but not limited to:

- Full on vineyard mode - currently in bud break
- Driving around she noted everyone is in the same spot
- Starting off really hot weather wise
- Fruit loads are looking normal
- Watching the weather and hoping for moisture
- Has been humid and getting on top of mildew control

- The warm weather has brought out the crowds and tasting rooms are in full swing

Legislative Report

Roger Batt, Legislative Educator, made his presentation to the Board. Batt highlighted the three (3) pieces of legislation, which were killed, and would have impacted the Idaho Wine Commission and wineries.

Those were: House Bills 12, 91 and 170

AG LAND PRESERVATION

H377 was introduced by Representative Kevin Andrus to be discussed throughout the post Session interim period. The bill establishes Agricultural Protection Areas (APA) in Idaho. Farmers and ranchers may apply to their local government entity to voluntarily submit their lands into an APA. During the time where the farmer or rancher has those lands within an APA, they receive monetary compensation, tax incentives and/or property tax reductions. The goal of H377 was to attempt to strike a balance between preserving farmland while at the same time protecting private property rights. H377 will be discussed by many agricultural leaders and organizations throughout the 2023 interim. It is the hope of those involved that a negotiated draft will be presented during the 2024 Legislative Session. Batt plans to present at the next board meeting.

CURRENT EFFORTS

The Idaho Grape & Wine Commission will continue to work on the Ada County issue as well as the Legislation on local government pre-emption. The next step on the local government preemption legislation is to go through the EALS process with the Governor's Office. The Idaho Wine Commission worked hard on educating new legislators and in hopes IWC can bring this topic up. B. Smith & Batt will work on getting draft legislation through the EALS process.

Dolsby presented a spreadsheet to the board about assessment increase options. Dolsby stressed it could be an uphill battle for the industry and with it not being a tremendous uptick in funds, she posed the question to the Board if it's worth it. B. Smith added the Governor's Office didn't indicate if they would support an assessment raise. Dolsby gave the option of going to pay to play for opportunities for our industry.

Batt stated it would be some work to get an assessment raise passed in the next legislative session. Ideas were thrown around about donating options in the form of assessments. Potter suggested doing a survey to the industry. Survey will be created by the Idaho Wine Commission for the industry.

Presentation - Juliet Marshall, PhD, University of Idaho

Juliet Marshall presented to the board virtually with updates on the Parma Research Center. Highlights included:

- Focus of new faculty on extension and research
- Additional positions with top priority focus on Parma
 - wine, grapes and small fruits
 - starting the development with the grape industry
 - interested in wanting input with industry needs
- Looking into the appropriate funding first and hopefully will be within a year.
- Creating a job description with the help from the Idaho Grape Growers and Wine Producers Commission
- Cragin offered suggestions for creating job description
 - pesticides being one of the biggest issues

- needing education to the industry on how to apply these chemicals
- Pasculli also adding the importance of sustainability and how to manage in a cost effective way

Dolsby asked about a timeline for Marshall to get her the full information and Marshall requested us to have a good list within 1-2 months.

Marshall then asked a question if anyone from our Board would be available to talk at AgTalk Tuesday since they would like to expand to the wine industry.

Marshall also requested to have someone in our industry be on the plant science advisory board. Cragin agreed to join the plant science advisory board.

B. Smith presented the draft budget to the Board. B. Smith wished she had more information on the Excise Tax Amendments to give to the Board and she mentioned just receiving the list on who she needs to still amend their Excise Tax. B. Smith will continue to work closely with the Idaho Tax Commission to ensure the Excise Tax Amendments get processed. Dolsby highlighted a vineyard/grower tour in California to bring prospects to Idaho that was added to the budget since the last time they saw the draft at the April Board Meeting.

Staff Reviews - Executive Session- Idaho Code Section 74-206 -

74-206. EXECUTIVE SESSIONS — (1) An executive session at which members of the public are excluded may be held, but only for the purposes and only in the manner set forth in this section. The motion to go into executive session shall identify the specific subsections of this section that authorize the executive session. There shall be a roll call vote on the motion and the vote shall be recorded in the minutes. An executive session shall be authorized by a two-thirds (2/3) vote of the governing body. An executive session may be held:

(b) To consider the evaluation, dismissal or disciplining of, or to hear complaints or charges brought against, a public officer, employee, staff member or individual agent, or public school student;
